

# CLIMATE METRICS DISCLOSURE FOR FUNDS MANAGED AND OPERATED BY INVESCO HONG KONG LIMITED

Data Updated: as of 30th June 2023

## **Background**

Environmental and climate factors could present material financial risks on investments. In line with the "Environmental Risk Management Policy" adhered to by Invesco Hong Kong Limited ("IHKL"), material environmental and climate risks are taken into consideration as part of investment processes. The following report summarizes the portfolio carbon footprint, a key climate metric of selected funds.

## Climate Metric - Portfolio Carbon Footprint

In line with regulatory requirement, carbon footprint data is monitored for each fund using the formula as follows, where "portfolio carbon footprint is a representation of carbon emissions normalized by portfolio's market value and expressed in tons of carbon dioxide equivalent emissions (Co2e) per million dollars invested".
