Notice of the Sources of Fund Distribution

This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.6629(Class R6), \$0.6128(Class Y), \$0.4794(Class A), \$0.0773(Class C) per share from net investment income; and (2) \$0.1905(Class R6), \$0.1905(Class Y), \$0.1905(Class C) per share from return of principal.
